103.3 COUNTRY "DYLAN MARLOWE ALBUM RELEASE PARTY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WKDF-FM ("Station"), owned and operated by Cumulus Broadcasting LLC, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday, on the Station website www.1033country.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **103.3 Country "Dylan Marlowe Album Release Party"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - (e) Follow 103.3 Country on Instagram.

Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified. Entry comments that are removed and/or blocked by the Station and/or by Instagram will be deemed not entered in the Contest.

This Contest is in no way sponsored, endorsed, administered by, or associated with Instagram. By submission of an entry, an entrant releases Instagram from any responsibility or liability for the Contest's administration, prizes, or promotion. An entrant is providing entry information to the Station and not to Instagram.

- 3. **Winner Selection.** At or around 10:00am on October 10, 2024, Station will select a minimum of one (1) entry for the Prize in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using Instagram Direct Messages via the 103.3 Country account and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within one (1) day of notification will result in disqualification and forfeiture of the prize.

IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.
