103.3 COUNTRY "KELSEA BALLERINI WINNING WEEK" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WKDF-FM ("Station"), owned and operated by Cumulus Broadcasting LLC, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday, on the Station website www.1033country.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **103.3 Country "Kelsea Ballerini Winning Week"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. - 2. Contest Period. The Contest will begin at 8:30am CT on October 28, 2024, and will run through 9:30am CT on November 1, 2024 (the "Contest Period"). The Station's computer is the official timekeeping device for this Contest.
- 3. **How to Enter and Win.** Listen to the Station during the Contest Period. At or around 9:00am CT each weekday during the Contest Period (a "Selection Day"), when the station plays the "cue-to-call", listeners must call the Station at 615-737-1033. Caller nine (9), or any other number announced at the time of the cue-to-call, to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's full legal name, email address, phone number, and home address, subject to verification and compliance with these Contest Rules. All entries may be played on air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest onair may be diminished. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify the winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. **LIMIT ONE PRIZE PER PERSON.**

A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
