103.3 COUNTRY "OPRY NEXTSTAGE LIVE WINNING WEEK" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WKDF-FM ("Station"), owned and operated by Cumulus Broadcasting LLC, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday, on the Station website www.1033country.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **103.3 Country "Opry NextStage Live Winning Week"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 2. Contest Period. The Contest will begin at 11:00am CT on October 14, 2024, and will run through 12:00pm CT on October 17, 2024 (the "Contest Period"). The Station's computer is the official timekeeping device for this Contest.
- 3. How to Enter and Win. Listen to the Station during the Contest Period. At or around 11:00am CT each weekday during the Contest Period (a "Selection Day"), when the station plays the "cue-to-call", listeners must call the Station at 615-737-1033. Caller nine (9), or any other number announced at the time of the cue-to-call, to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's full legal name, email address, phone number, and home address, subject to verification and compliance with these Contest Rules. All entries may be played on air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify the winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. LIMIT ONE PRIZE PER PERSON.

If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. The approximate retail value ("ARV") of each prize is One Hundred Dollars (\$100.00).

Entry Conditions and Release. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
