103.3 COUNTRY "NATE SMITH WINNING WEEK WITH VIP GRAND PRIZE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WKDF-FM ("Station"), owned and operated by Cumulus Broadcasting LLC, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday, on the Station website www.1033country.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **103.3 Country "Nate Smith Winning Week With VIP Grand Prize"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries may be played on air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal.
