103.3 COUNTRY'S "SINNERS ADVANCE SCREENING WEB" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WKDF-FM ("Station"), owned and operated by Cumulus Broadcasting LLC, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday, on the Station website www.1033country.com, or by sending a self-addressed, stamped envelope to the above address.

Any attempt by any participant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified.
